Certification is a form of credentialing in a profession. It is the process by which a non-government organization grants recognition to persons who have met certain standards defined by that organization. Certification is designed to promote and maintain integrity and quality.

A tool for marketing:

Employers see the credential as a basis for advancement.

Courts and Probation Departments are interested in proof of competency before making referrals.

You can use it in marketing and beginning your own practice or clinic.

You can use the CART as part of your credential after your name.

If you want a specialty that managed care is short on, this is it... angry and violent clients.

All counselors, mental health professionals, clergy and anyone who works or plans to work with angry people.
